




## **Greetings from the ECE Program and Field Placement Coordinator – Karen Davis**

#### Field Placement Attendance

Students are accountable to complete an online attendance each week by Sunday at midnight to confirm their hours/days of placement each week.

Mentors or designate receive a copy of the attendance each week by email. Email address highlighted on the Commitment of Practice.

Students are responsible to check the correct email address of their Mentor and enter this each week on the online form.

Mentors are only required to contact the Field Placement Specialist if there is a discrepancy on the submission.

All schedule adjustments (make up days) are approved by the Field Placement Specialist and students confirms with Mentor. Student's must complete the placement within the timelines provided.

## **Myths vs Facts**

#### Myths

- Students are not required to complete an orientation prior to placement starting.
- Students are not allowed to change diapers.
- Students can work whatever shift and hours for placement.
- Students are not required to plan or implement requirements while on placement.
- Student do not have to provide the Mentor a hard copy of the Learning Outcome Feedback Form on the first day of placement.
- Students can give their planning form to the Mentor on the day of implementation.
- If students are not successful on placement as identified by the placement site, Mohawk just moves them along to then next placement.

#### **Facts**

- Students must complete an orientation prior to starting placement as this is a college requirement. This gives them the opportunity to show sites their requirements for placement.
- Students are required to change diapers and participate in all routines. (unless site has a policy stating otherwise)
- Students are to work the full time shift as if they were hired in the position. Any schedule adjustments must be done with the FPS.
- All requirements in the LOFF must be completed during the 24 days of placement.
- Yes students need to give the Mentor a printed copy of the LOFF regardless if they have a printer or not.
- Student MUST follow the Commitment of Practice while on placement.
- Mohawk supports the placement Mentors/Site will placement outcomes.





## REQUEST FOR SUPPORT FOR FIELD PLACEMENT OPPORTUNITIES


We are in desperate need of your support to host as many Field

#### College of ECE – Policy Statement Regarding Practicum

- **5.1 Hours** The total amount of time that students spend in practicum is at least 500 hours. This is an absolute minimum and programs are expected to require students to complete more practicum hours.
- **5.2 Supervision and mentorship** Students must be supervised and mentored by RECEs (i.e., members of the College in good standing).
- **5.3 Settings** Programs must:
- offer practicum placements in a variety of settings that reflect the range and diversity of early childhood education practice settings, and
- require students to complete practicum placements at different sites.
- **5.4 Age groupings** Programs must:
- offer practicum placements among all three age groupings, and
- require students to have direct experience and contact with different age groupings through one or more of their practicum placements.
- **5.5 Scope of practice** Programs must require and ensure that the scope of duties that students carry out during practicum placements will relate to, and be consistent with, early childhood education practice.
- **5.6 Opportunity for reflection** Programs must design practicum, so that there are opportunities for students to reflect on their practice during their placement
- **5.7 Assessment and evaluation** Programs must design practicum so that students' performance is assessed and evaluated.
- **5.8 Policies and quality assurance** Programs must develop and implement policies and/or guidelines that support quality assurance in the practicum component of the program.
