By His Excellency Charles Lawrence Esq. Captain General and Governor in Chief in and over His Majesty's Province of Nova Scotia or accadie. Vice Admiral of the Same Etc. Etc. To Isaac Deschamps Esq. I Do Hereby Constitute and appoint you to be Truckmaster at Fort Edward, Pizequid in the Kings County, for carrying on Commerce, in Behalf of The Government of This Province, with the Indians, and you are to Conduct yourself at all times with care and Fidelity according to the Instructions Herewith Deliverd you or that you Shall hereafter Receive from myself or the Commander in Chief.

Given under my Hand & Seal at Halifax the Sixteenth Day of June 1760 in the thirty third year of His Majesty's Reign Chas: Lawrence

At a Treaty of Peace concluded at Halifax On the Twenty third of February 1760. Between His Excellency Charles Lawrence Esq. Captain General and Governor in Chief in and Over His Majestys Province of Nova Scotia &c -- And Mitchell Neptune Chief of the Tribe of the Indians of Passamaquoddy and Belloni Glode Captain of the Tribe of Indians of Saint Johns River within the said Province on Behalf of the said Tribes; It was Agreed that Commerce should be carried on at a Truckhouse to be Established at Fort Frederick according to the Overall Rates following Vizt ---

That a Pound of the best Spring Beaver be valued at Five Shillings and that Two pounds of Spring Beaver be Esteemed equal to Three pounds of Fall Beaver. --

That a Loutre or Otter Skin be Esteemed equal to a pound of Spring Beaver That Three Martre, Sable or Matrin Skins be Esteemed equal to a pound of Spring Beaver

That a Pequant or Fisher Skins be equal to a pound of Spring Beaver That Six Toins Vizons or Minks Skins equal to a pound of Spring Beaver That An Ours or Bearskin large and in good Season be equal to a a pound and one half of Spring Beaver and others in proportion. That a Renard Rouge or Red Fox Skin equal to a half a pound of Spring Beaver

That a Renard Noir or Black Fox Skin be equal to Two pounds of Spring Beaver

That a Renard Argente or Silver Fox Skin be equal to Two pounds & a Half of Spring Beaver

That Ten Rats Muque or Muskrat Skins be equal to a pound of Spring Beaver.

You are to govern yourself by the above Rates & Regulations in your Commerce with the Indians of your district
